Resolution of the Board of Commissioners

At the regular meeting of the Lincoln County Board of Commissioners on December 17, 2013, Commissioner Hansen moved, seconded by Commissioner Evers to forego the requirement of the petitioners of County Ditch #33 Improvement to provide additional security in the amount of \$12,000.00 for the proposed Improvement. The additional \$12,000 expense has occurred due to the involvement of the Army Corp of Engineers in the permitting process. The Board determined that the Petitioners should not be immediately responsible for the additional expense. Rather, that the Drainage Authority will carry the additional \$12,000 expense without requiring the Petitioners to post additional bond.

Based on the prior resolution, at the regular meeting of the Lincoln County Board of Commissioners on January 7, 2014, Commissioner Joan Jagt moved, seconded by Commissioner Larry Hansen to direct the Auditor to carry the additional \$12,000 expense related to Corps of Engineers review and permitting until such time as the Improvement Project is either ordered or dismissed, without requiring the Petitioners to post additional bond for the \$12,000 expense. The Petitioners are not, however, relieved from their obligation to pay all costs should the improvement Project be dismissed. Upon adoption of an Order by the Drainage Authority either ordering the improvement or dismissing the petition, expenses of the project, including the additional \$12,000 expense will be recouped as follows:

If the Improvement Project is ordered, expenses will be reimbursed to Lincoln County as project costs.

If the Petition is dismissed, expenses will be reimbursed from the Petitioners to Lincoln County, including the \$12,000 additional expense.

Minimum charge set at \$45.00. This assessment is to be applied to payable 2014 property tax statement and years thereafter.
